

Chief Warrant Officer Todd Sinclair



Chief Warrant Officer Todd Sinclair joined the CAF in May 1985 under the Youth Training Employment Plan as an Infanteer. He completed basic training and then was posted to the 2nd Battalion Royal Canadian Regiment (2 RCR) in Gagetown, NB. As a member of 2 RCR he deployed on Op Salon (The Oka Crisis) from Jul-Sep 1990 as an Armoured Personnel Carrier Ambulance Driver. In Aug 1991, CWO Sinclair remastered and joined the Canadian Forces Dental Services.

After completing his TQ3 course in Borden, he was posted to 14 Dental Unit Detachment Shilo MB. In Jul 1996, he was posted to 11 Dental Unit Det Esquimalt and, one year later, he was posted to Petawawa where he spent time at 2 Field Ambulance, 1 Canadian Field Hospital and the Dental Detachment. While at 2 Fd Amb he deployed on Op Recuperation (Ice Storm 1998) in Ottawa, ON and in May 1999 to Op Parasol (Trenton, ON) to provide dental support to the displaced personnel from Kosovo.

In July 2002, he was promoted to the rank of MCpl and posted to once again to 1 DU Det Esquimalt. He was promoted to the rank of Sgt in Jan 2005 and posted to 1 Dental Unit Detachment Moose Jaw in Jul 2006. In 2007, he deployed aboard the USS Nassau for a nine week training exercise with the US Navy to Spain.

In Aug 2008, he was promoted to WO and posted to 1 DU Det Halifax. From Sep 2009 until April 2010 he deployed on Op Athena (Afghanistan) as part of Roto 8. There he worked as the Senior Dental Technician for the US led Role 3 Hospital, the CSM for the Canadian Role 3 and also as a mentor to the local Afghan dentists at the Kandahar Regional Military Hospital. He was awarded the General Campaign Star, the US Army Commendation Medal and a Commander CEFCom Commendation.

Upon his return from theatre, he attended the yearlong French course in Shearwater, NS. In Jul 2011, he was posted to the Canadian Forces Health Services Training Center as the Dental Standards Warrant Officer. In February 2012, he was promoted to MWO and took over as CSM Armstrong Company. In Jul 2015, he was posted to 1 Dental Unit Headquarters in Ottawa as the Regional MWO East and West. In Jun 2016, he was promoted to Chief Warrant Officer and appointed Regimental Sergeant Major of 1 Cdn Fd Hospital. On 16 May 2019, CWO Sinclair was appointed RCDC Branch CWO.

CWO Sinclair and his wife Rose have two sons, Justing and TJ, and three grandchildren: Roland, Deklyn and Molly.
